

**Amendment 1 of the
BYLAWS
Of the
Zeta Iota Alumni of SJSU Corp**

ARTICLE I

Name

Section 1. The By-Laws as written and accepted on August 31, 2020 are hereby incorporated in this document

ARTICLE II

Board of Directors

Section 1. The authorized number of Directors shall be seven (7) and may be changed to no less than three (3) and no more than nine (9) by a vote of a majority of the current directors. Board members shall be elected by the voting members. Once elected to the board, the board members shall elect officers. Board members shall have terms of 2 years. If there exists a vacancy on the board, the current board members may appoint a member to fill out a term by a majority vote of the current board members. The initial officers became board members upon acceptance of the original By-laws. Officer titles can be used interchangeably as follows: President / Worthy Commander; Vice-President / Worthy Lt. Commander; Treasurer / Worthy Treasurer; Sargent at Arms / Worthy Sentinel and any other titles that conform to designations described by Sigma Nu Headquarters.

ARTICLE III

Meetings

Section 1. An annual meeting shall be conducted of each year. Voting members may call for an open meeting to be scheduled when at least 10 voting members request such a meeting in writing to the Secretary. All members may attend the annual meeting and any other open meetings called by the board or an open meeting as requested by voting members. Voting members may vote at any annual or open meeting. Directors may call for an open meeting at any time.

ARTICLE IV

Quorum

Section 1. A quorum will exist when at least 55 percent of the authorized number of directors are present to vote or have obtained a proxy from another board member to vote on his behalf.











ARTICLE V
